It is required that your firm's Statement of Qualifications (RSMo8.285 through 8.291) and an Affidavit of Compliance with the federal work authorization program along with a copy of your firm's E-Verify Memorandum of Understanding (15 CSR 60-15020) be submitted with your firm's Letter of Interest.

We request all responses be received by 3:00pm CST August 29, 2014, at the City of Fenton City Hall, 625 New Smizer Mill Rd. Fenton, MO 63026.
