Proposed Improvement:	<p>Pedestrian/bicycle trail along Forum Boulevard including a pedestrian/bicycle bridge over Hinkson Creek together with trail connections to MKT trail and nearby sidewalks.</p> <p>The proposed project is a pedestrian and bicycle trail and bridge adjacent to an existing roadway. The existing roadway and bridge are currently two lane facilities which will be widened to a 5 lanes in the future. It is desired that the pedestrian/bicycle bridge be constructed in a location that will either remain in service during and after the bridge widening, or be an integral component of the future bridge widening.</p>
